Directions for Using Your Ace Grab Bag

1. Take care of the bag

The ACE GRAB BAG is very strong but, if damaged, may weaken. After unpacking, check your bag and avoid puncturing or tearing it during use. Do not dispose of any sharp objects, hot ashes or anything that may penetrate it.

The ACE GRAB BAG is for a single use only and will not be returned or replaced

2. Positioning the bag (Important please read carefully)

Once you start filling the bag you may not be able to move it. Any attempt to do so may result in damage to the bag or yourself. Therefore, before you start to fill it you must ensure the following:

- The Ace Grab Bag must be left within 4 metres (13 feet) of the public highway.
- The highway must be at least 3 metres (10 feet) wide for the lorry.
- The bag must be well clear of any walls, trees, parked cars, overhead wires or anything else that might obstruct the operation of the crane.
- You should not place your ACE GRAB BAG on public highways, pavements or verges without obtaining prior permission to do so from your local authority.

3. Filling The Bag

The bag is designed to hold a maximum of 1 tonne weight. You must distribute the weight evenly and not overload or fill the bag above the top edge. If the bag is overfilled it may result in us not being able to collect it and a charge incurred for a wasted trip.

As a guide:

- **Heavy Soil** = bag filled approx 2/3
- **Rubble** = bag approx ¾ full
- **Builders Waste** = level loads

Note: The ACE GRAB BAG is intended for disposal of ordinary household, garden and builders waste only. It must not be used to dispose of tyres, asbestos, large tree roots, fridges/freezers, batteries, fluorescent tubes, paint containers, gas bottles, oils, liquids, chemicals, food waste and electrical goods.

You should be aware that failure to comply with these directions may put you in breach of UK environmental protection laws.

If in doubt, please call our office for advice.

4. Contact us to arrange collection

Our office is open from 7.30am to 5:30pm Monday to Friday and from 7.30am to 1pm on Saturdays.

When you are ready to have your bag collected please call one of the numbers below. You will need to tell us the type of waste you have filled your bag with and the location of the bag. We will endeavour to collect within 5 working days

5. Collection

Ensure that we can collect the bag at anytime, even if nobody is there. If we are unable to collect the bag, you may be charged for a wasted journey charge.

Please note that we reserve the right to refuse collection if the bag is positioned beyond the reach of our vehicle, access or crane operation is obstructed or if the bag is overloaded, damaged or contains anything other than ordinary household, garden or builders waste. If we refuse collection for any reason you will not be entitled to a refund.
